HALLUCINOGENS ALTER PERCEPTION AND COGNITION, SOMETIMES RESULTING IN DANGEROUS BEHAVIOR OR PSYCHOLOGICAL DISTRESS. UNDERSTANDING THESE DIVERSE EFFECTS IS CRUCIAL FOR RECOGNIZING SIGNS OF ABUSE AND PROVIDING APPROPRIATE INTERVENTIONS.

LEGAL ASPECTS AND REGULATIONS RELATED TO SUBSTANCE USE
