UNDERSTANDING THE AP GOV FINAL EXAM FORMAT

THIS SECTION TYPICALLY ALLOWS 100 MINUTES AND IS DIVIDED INTO TWO PARTS: CONCEPTUAL ANALYSIS AND QUANTITATIVE ANALYSIS.

SCORING AND WEIGHT

PUBLIC POLICY
