FOUNDATIONS OF AMERICAN DEMOCRACY

MONTESQUIEU'S IDEA OF SEPARATION OF POWERS INFORMS THE DIVISION OF GOVERNMENT FUNCTIONS INTO LEGISLATIVE, EXECUTIVE, AND JUDICIAL BRANCHES. IMPORTANT FOUNDATIONAL DOCUMENTS

SEVERAL DOCUMENTS ARE CRITICAL TO UNDERSTANDING THE FOUNDATION OF THE U.S. GOVERNMENT. THE DECLARATION OF INDEPENDENCE OUTLINES THE REASONS FOR AMERICAN INDEPENDENCE AND ARTICULATES NATURAL RIGHTS. THE ARTICLES OF CONFEDERATION REPRESENT THE FIRST ATTEMPT AT NATIONAL GOVERNANCE BUT REVEAL WEAKNESSES THAT LED TO THE DRAFTING OF THE CONSTITUTION. THE FEDERALIST PAPERS, PARTICULARLY FEDERALIST NO. 10 AND NO. 51, ARGUE FOR A STRONG FEDERAL GOVERNMENT AND EXPLAIN MECHANISMS LIKE CHECKS AND BALANCES AND THE EXTENDED REPUBLIC. MASTERY OF THESE DOCUMENTS IS VITAL FOR AP GOV UNIT 1 TEST PRACTICE.

CORE PRINCIPLES OF DEMOCRACY

UNIT 1 EMPHASIZES SEVERAL CORE PRINCIPLES THAT SHAPE AMERICAN DEMOCRACY:

- **FEDERALISM:** DISTRIBUTION OF POWER BETWEEN NATIONAL AND STATE GOVERNMENTS.

THE CONSTITUTION AND FEDERALISM

THE CONSTITUTION IS THE SUPREME LAW OF THE UNITED STATES AND A CORNERSTONE OF AP GOV UNIT 1 TEST PRACTICE. THE STRUCTURE OF THE CONSTITUTION

THE CONSTITUTION CONSISTS OF A PREAMBLE, SEVEN ARTICLES, AND 27 AMENDMENTS. THE PREAMBLE SETS FORTH THE PURPOSES OF GOVERNMENT. ARTICLES I THROUGH III ESTABLISH THE LEGISLATIVE, EXECUTIVE, AND JUDICIAL BRANCHES. ARTICLE IV ADDRESSES STATE RELATIONS, ARTICLE V DETAILS THE AMENDMENT PROCESS, ARTICLE VI CONTAINS THE SUPREMACY CLAUSE, AND ARTICLE VII OUTLINES RATIFICATION PROCEDURES. UNDERSTANDING THESE COMPONENTS IS CRITICAL FOR ANSWERING AP GOV UNIT 1 TEST PRACTICE QUESTIONS ACCURATELY.

FEDERALISM EXPLAINED

FEDERALISM IS A SYSTEM WHERE POWER IS SHARED BETWEEN A CENTRAL GOVERNMENT AND CONSTITUENT POLITICAL UNITS—STATES. STUDENTS MUST UNDERSTAND THE DIFFERENT TYPES OF POWERS:

- **ENUMERATED POWERS:** POWERS EXPLICITLY GRANTED TO THE NATIONAL GOVERNMENT BY THE CONSTITUTION.

- **CONCURRENT POWERS:** POWERS SHARED BY BOTH STATE AND NATIONAL GOVERNMENTS.

ADDITIONALLY, THE EVOLVING NATURE OF FEDERALISM—DUAL FEDERALISM, COOPERATIVE FEDERALISM, AND NEW FEDERALISM—PLAYS A KEY ROLE IN THE TEST'S CONCEPTUAL QUESTIONS.

IMPORTANT SUPREME COURT CASES ON FEDERALISM

SEVERAL LANDMARK SUPREME COURT CASES HIGHLIGHT THE BALANCE OF FEDERAL AND STATE POWER. CASES LIKE *MCCULLOCH V. MARYLAND* AFFIRMED FEDERAL SUPREMACY AND THE NECESSARY AND PROPER CLAUSE. *GIBBONS V. OGDEN* EXPANDED THE INTERPRETATION OF THE COMMERCE CLAUSE, INCREASING FEDERAL AUTHORITY. MORE RECENT CASES, SUCH AS *UNITED STATES*

V. LOPEZ, HAVE EMPHASIZED LIMITS ON FEDERAL POWER. FAMILIARITY WITH THESE DECISIONS IS INDISPENSABLE FOR AP GOV UNIT 1 TEST PRACTICE.

POLITICAL BELIEFS AND BEHAVIORS

POLITICAL SOCIALIZATION

PUBLIC OPINION AND POLLING

PUBLIC OPINION IS THE AGGREGATE OF INDIVIDUAL ATTITUDES ABOUT POLITICAL ISSUES, LEADERS, AND INSTITUTIONS. POLLING TECHNIQUES, QUESTION WORDING, SAMPLING METHODS, AND MARGIN OF ERROR ARE ESSENTIAL CONCEPTS TO GRASP. ACCURATE INTERPRETATION OF POLLS CAN PREDICT ELECTION OUTCOMES AND GUIDE POLICY DECISIONS. THESE ANALYTICAL SKILLS ARE CENTRAL TO MASTERING AP GOV UNIT 1 TEST PRACTICE.

VOTING BEHAVIOR AND POLITICAL PARTICIPATION
