THE AP GOVERNMENT EXAM IS DESIGNED TO ASSESS STUDENTS' UNDERSTANDING OF THE UNITED STATES GOVERNMENT AND POLITICS THROUGH A COMBINATION OF MULTIPLE-CHOICE QUESTIONS AND FREE-RESPONSE ITEMS. THE EXAM IS ADMINISTERED ANNUALLY AND TYPICALLY LASTS AROUND TWO HOURS, DIVIDED INTO TWO MAIN SECTIONS. FAMILIARITY WITH THE FORMAT IS ESSENTIAL FOR EFFECTIVE PREPARATION AND TIME ALLOCATION DURING THE EXAM.

MULTIPLE-CHOICE SECTION

FREE-RESPONSE SECTION

THE FREE-RESPONSE SECTION INCLUDES FOUR QUESTIONS TO BE ANSWERED IN 1 HOUR. THIS SECTION EVALUATES STUDENTS' ABILITIES TO CONSTRUCT COHERENT ARGUMENTS, ANALYZE POLITICAL SCENARIOS, AND INTERPRET DATA RELATED TO GOVERNMENT AND POLITICS. THE QUESTIONS TYPICALLY INVOLVE DOCUMENT ANALYSIS, QUANTITATIVE REASONING, AND CONCEPTUAL EXPLANATIONS THAT DEMAND CLEAR, WELL-ORGANIZED WRITING.

EXAM TIMING AND STRUCTURE OVERVIEW

CONSTITUTIONAL UNDERPINNINGS OF THE U.S. GOVERNMENT

INSTITUTIONS OF NATIONAL GOVERNMENT

THIS CONTENT AREA EXAMINES THE THREE BRANCHES OF GOVERNMENT—THE LEGISLATIVE, EXECUTIVE, AND JUDICIAL BRANCHES—DETAILING THEIR STRUCTURES, FUNCTIONS, AND INTERACTIONS. IT ALSO EXPLORES CONGRESS'S LAWMAKING PROCESS, PRESIDENTIAL POWERS, AND THE FEDERAL COURT SYSTEM.

PUBLIC POLICY

UNDERSTANDING THE POLICYMAKING PROCESS INCLUDES STUDY OF HOW POLICIES ARE FORMULATED, IMPLEMENTED, AND EVALUATED. STUDENTS LEARN ABOUT DOMESTIC AND FOREIGN POLICIES, ECONOMIC AND SOCIAL POLICY ISSUES, AND THE IMPACT OF POLITICAL INSTITUTIONS ON POLICY OUTCOMES.

THIS SECTION COVERS INDIVIDUAL RIGHTS GUARANTEED BY THE CONSTITUTION, INCLUDING THE BILL OF RIGHTS, AND IMPORTANT SUPREME COURT DECISIONS THAT HAVE SHAPED PROTECTIONS RELATED TO FREEDOM OF SPEECH, RELIGION, DUE PROCESS, AND EQUAL PROTECTION UNDER THE LAW.

ALLOCATE TIME BASED ON THE NUMBER OF QUESTIONS AND SECTIONS. FOR EXAMPLE, AIM TO SPEND ABOUT 1.5 MINUTES PER MULTIPLE-CHOICE QUESTION AND ROUGHLY 15 MINUTES PER FREE-RESPONSE QUESTION TO LEAVE TIME FOR REVIEW.

REVIEW ANSWERS WHEN POSSIBLE

IF TIME PERMITS, REVIEW RESPONSES TO CHECK FOR MISTAKES OR INCOMPLETE ANSWERS, ESPECIALLY IN THE FREE-RESPONSE SECTION WHERE CLARITY AND COMPLETENESS ARE CRITICAL.

SCORING AND AP CREDIT OPPORTUNITIES

THE AP GOVERNMENT EXAM IS SCORED ON A SCALE FROM 1 TO 5, WITH 5 BEING THE HIGHEST POSSIBLE SCORE. UNDERSTANDING THE SCORING PROCESS AND HOW COLLEGES RECOGNIZE AP GOVERNMENT SCORES HELPS STUDENTS APPRECIATE THE VALUE OF THEIR EFFORTS.

SCORE COMPOSITION

MANY COLLEGES AND UNIVERSITIES GRANT COURSE CREDIT OR ADVANCED PLACEMENT FOR SCORES OF 3 OR HIGHER ON THE AP GOVERNMENT EXAM. THIS CAN REDUCE THE TIME AND COST REQUIRED TO COMPLETE A COLLEGE DEGREE AND PROVIDE STUDENTS WITH FOUNDATIONAL KNOWLEDGE FOR FURTHER POLITICAL SCIENCE STUDIES.

SCORE REPORTING

STUDENTS RECEIVE THEIR SCORES SEVERAL WEEKS AFTER THE EXAM DATE. IT IS ADVISABLE TO SEND SCORES TO PROSPECTIVE COLLEGES EARLY TO ENSURE CONSIDERATION DURING ADMISSIONS AND PLACEMENT PROCESSES.
