TRADE NETWORKS AND ECONOMIC EXCHANGE

ROUTES ALLOWED THE EXCHANGE OF SILK, SPICES, PRECIOUS METALS, TEXTILES, AND IDEAS. CARAVANSERAI AND TRADING CITIES ALONG THE SILK ROADS FLOURISHED AS HUBS OF COMMERCE AND CULTURAL INTERACTION, CONTRIBUTING SIGNIFICANTLY TO THE ECONOMIES OF EMPIRES LIKE THE TANG DYNASTY AND ABBASID CALIPHATE.

INDIAN OCEAN TRADE

THE INDIAN OCEAN TRADE NETWORK WAS A MARITIME SYSTEM LINKING EAST AFRICA, THE MIDDLE EAST, SOUTH ASIA, AND SOUTHEAST ASIA. MONSOON WINDS FACILITATED REGULAR SEA VOYAGES, ENABLING THE TRANSPORT OF BULK GOODS SUCH AS TIMBER, SPICES, AND CERAMICS. THIS TRADE PROMOTED URBANIZATION IN PORT CITIES AND FOSTERED MULTICULTURAL COASTAL SOCIETIES.

TRANS-SAHARAN TRADE

THE TRANS-SAHARAN TRADE ROUTES CONNECTED WEST AFRICA WITH NORTH AFRICA AND THE MEDITERRANEAN WORLD. GOLD, SALT, IVORY, AND SLAVES WERE PRIMARY COMMODITIES TRADED ACROSS THE SAHARA DESERT. THIS TRADE SUPPORTED THE RISE OF POWERFUL WEST AFRICAN EMPIRES AND THE SPREAD OF ISLAM INTO SUB-SAHARAN AFRICA.

ECONOMIC INNOVATIONS

- USE OF PAPER MONEY AND CREDIT SYSTEMS, PARTICULARLY IN SONG CHINA.

RELIGIOUS AND CULTURAL DEVELOPMENTS

RELIGIOUS BELIEFS AND CULTURAL PRACTICES PLAYED A PIVOTAL ROLE IN SHAPING SOCIETIES DURING AP WORLD HISTORY UNIT 3. THE SPREAD OF MAJOR WORLD RELIGIONS AND PHILOSOPHICAL SYSTEMS INFLUENCED POLITICAL LEGITIMACY, SOCIAL STRUCTURES, AND CULTURAL EXPRESSION.

HINDUISM REMAINED DOMINANT IN SOUTH ASIA, WITH TEMPLE-BUILDING AND RELIGIOUS TEXTS REINFORCING SOCIAL HIERARCHIES AND CULTURAL IDENTITY. BOTH RELIGIONS INFLUENCED ARTISTIC EXPRESSION AND POLITICAL AUTHORITY.

CHRISTIANITY AND OTHER BELIEF SYSTEMS

CHRISTIANITY PERSISTED AND EVOLVED WITHIN THE BYZANTINE EMPIRE AND EUROPE, SHAPING MEDIEVAL POLITICAL STRUCTURES AND CULTURAL LIFE. IMPACT OF THE ENVIRONMENT
