THE SAFAVID EMPIRE ESTABLISHED SHI'A ISLAM AS A UNIFYING FORCE IN PERSIA, WHILE THE MUGHAL EMPIRE UNIFIED MUCH OF THE INDIAN SUBCONTINENT. THESE EMPIRES UTILIZED GUNPOWDER WEAPONRY EFFECTIVELY TO MAINTAIN POWER AND EXPAND BORDERS, AND THEY FOSTERED RICH CULTURAL AND ARCHITECTURAL DEVELOPMENTS.

EUROPEAN POLITICAL EXPANSION

EUROPEAN STATES NOT ONLY BUILT OVERSEAS COLONIES BUT ALSO EXPERIENCED INTERNAL POLITICAL CHANGES. THE CONSOLIDATION OF MONARCHIES IN SPAIN, FRANCE, AND ENGLAND SET THE STAGE FOR GLOBAL COMPETITION. COLONIAL ADMINISTRATION SYSTEMS SUCH AS THE ENCOMIENDA AND VICEROYALTIES IN SPANISH AMERICA STRUCTURED IMPERIAL GOVERNANCE AND RESOURCE EXTRACTION.
