DEFINITION AND CONCEPT

- HOW DO STUDENT PERFORMANCE RESULTS COMPARE ACROSS SCHOOLS WITH SIMILAR DEMOGRAPHICS AND RESOURCES?
- WHAT ARE THE MEASURABLE EFFECTS OF TREATMENTS TESTED UNDER THE SAME CLINICAL TRIAL CONDITIONS?

- HOW DO GRADUATION RATES DIFFER AMONG PROGRAMS WITH IDENTICAL ENROLLMENT SIZES AND CURRICULA?

PERSONAL FINANCE

WHEN MANAGING PERSONAL FINANCES, APPLES TO APPLES QUESTIONS GUIDE INVESTMENT AND BUDGETING DECISIONS.

- WHAT ARE THE INTEREST RATES AND FEES FOR LOANS WITH THE SAME PRINCIPAL AMOUNT AND TERM?

HOW TO FORMULATE EFFECTIVE APPLES TO APPLES QUESTIONS

CRAFTING EFFECTIVE APPLES TO APPLES QUESTIONS REQUIRES CAREFUL CONSIDERATION OF THE COMPARISON CONTEXT AND OBJECTIVES. THE FOLLOWING GUIDELINES PROVIDE A STRUCTURED APPROACH TO QUESTION FORMULATION.

IDENTIFY COMPARABLE CRITERIA

WHENEVER POSSIBLE, FRAME QUESTIONS TO ELICIT QUANTITATIVE DATA RATHER THAN SOLELY QUALITATIVE OPINIONS. NUMERICAL DATA FACILITATES OBJECTIVE ANALYSIS AND REDUCES SUBJECTIVE BIAS.

TEST AND REFINE QUESTIONS

BEFORE FINALIZING, REVIEW THE QUESTIONS TO ENSURE THEY TRULY ENABLE APPLES TO APPLES COMPARISONS. SEEK FEEDBACK FROM STAKEHOLDERS OR EXPERTS TO IDENTIFY POTENTIAL GAPS OR AMBIGUITIES. REFINEMENT IMPROVES THE EFFECTIVENESS OF THE QUESTIONING PROCESS.

COMMON MISTAKES TO AVOID WHEN USING APPLES TO APPLES QUESTIONS

IGNORING QUALITATIVE DIFFERENCES
