## THIRD AMENDMENT

THE THIRD AMENDMENT PROHIBITS THE QUARTERING OF SOLDIERS IN PRIVATE HOMES WITHOUT THE OWNER'S CONSENT DURING PEACETIME. THIS AMENDMENT REFLECTS COLONIAL GRIEVANCES AGAINST BRITISH MILITARY PRACTICES.

## FOURTH AMENDMENT

THIS AMENDMENT PROTECTS CITIZENS FROM UNREASONABLE SEARCHES AND SEIZURES. IT REQUIRES LAW ENFORCEMENT TO OBTAIN WARRANTS BASED ON PROBABLE CAUSE TO CONDUCT SEARCHES, ENSURING PRIVACY AND SECURITY.

## FIFTH AMENDMENT

## SIXTH AMENDMENT

## SEVENTH AMENDMENT

THIS AMENDMENT PRESERVES THE RIGHT TO A JURY TRIAL IN CIVIL CASES WHERE THE VALUE IN CONTROVERSY EXCEEDS A CERTAIN AMOUNT, MAINTAINING A CHECK ON JUDICIAL AUTHORITY.

## EIGHTH AMENDMENT

THE EIGHTH AMENDMENT PROHIBITS EXCESSIVE BAIL OR FINES AND CRUEL OR UNUSUAL PUNISHMENT, PROTECTING INDIVIDUALS FROM HARSH PENALTIES.

## NINTH AMENDMENT

THE NINTH AMENDMENT STATES THAT THE ENUMERATION OF CERTAIN RIGHTS IN THE CONSTITUTION DOES NOT MEAN THAT OTHER RIGHTS ARE DENIED TO THE PEOPLE. IT RECOGNIZES THE EXISTENCE OF UNENUMERATED RIGHTS.

## TENTH AMENDMENT

THIS AMENDMENT RESERVES POWERS NOT DELEGATED TO THE FEDERAL GOVERNMENT TO THE STATES OR THE PEOPLE, REINFORCING THE FEDERAL SYSTEM OF GOVERNMENT.
