IMPORTANCE OF VISIBILITY AND SIGNALS

VISIBILITY PLAYS A CRITICAL ROLE IN NAVIGATION RULES. BOATERS SHOULD USE NAVIGATION LIGHTS, SOUND SIGNALS, AND OTHER COMMUNICATION METHODS TO INDICATE THEIR POSITION AND INTENTIONS, ESPECIALLY DURING LOW VISIBILITY CONDITIONS SUCH AS NIGHT OR FOG. PROPER USE OF THESE SIGNALS HELPS AVOID MISUNDERSTANDINGS AND COLLISIONS.

BOAT HANDLING AND MANEUVERING

EFFECTIVE BOAT HANDLING IS ESSENTIAL FOR SAFE OPERATION, PARTICULARLY IN VARYING WATER CONDITIONS AND CROWDED WATERWAYS. SMOOTH, GRADUAL MOVEMENTS ARE PREFERRED TO MAINTAIN STABILITY AND PASSENGER COMFORT.

STOPPING AND DOCKING PROCEDURES

STOPPING A BOAT SAFELY REQUIRES REDUCING SPEED GRADUALLY AND USING REVERSE THRUST IF AVAILABLE. DOCKING IS A CRITICAL SKILL INVOLVING APPROACH ANGLES, USE OF FENDERS, AND SECURING THE VESSEL WITH LINES. RIGHT-OF-WAY REGULATIONS

- POWER-DRIVEN VESSELS MUST YIELD TO VESSELS ENGAGED IN FISHING.
- SMALLER VESSELS YIELD TO LARGER VESSELS IN MOST CASES.

CROSSING, OVERTAKING, AND HEAD-ON SITUATIONS

IN CROSSING SITUATIONS, THE VESSEL APPROACHING FROM THE STARBOARD SIDE MUST BE GIVEN THE RIGHT-OF-WAY. WHEN OVERTAKING, THE OVERTAKING VESSEL MUST KEEP CLEAR OF THE VESSEL BEING PASSED. IN HEAD-ON ENCOUNTERS, BOTH VESSELS SHOULD ALTER COURSE TO STARBOARD TO PASS SAFELY ON THE PORT SIDE.

NAVIGATION AIDS AND MARKERS

THE CARDINAL SYSTEM USES MARKERS TO SHOW SAFE WATER DIRECTIONS RELATIVE TO HAZARDS, BASED ON COMPASS POINTS (NORTH, EAST, SOUTH, WEST). UNDERSTANDING THESE SYSTEMS IS CRITICAL FOR NAVIGATING SAFELY.

SAFETY PROCEDURES AND EMERGENCY PREPAREDNESS

- VISUAL DISTRESS SIGNALS SUCH AS FLARES OR FLAGS.

EMERGENCY PROCEDURES
