HISTORICAL CONTEXT AND BACKGROUND

THE BROWN VS BOARD OF EDUCATION WORKSHEET OFTEN BEGINS BY SETTING THE HISTORICAL CONTEXT OF RACIAL SEGREGATION IN THE UNITED STATES, PARTICULARLY IN THE EDUCATION SYSTEM. BOARD OF EDUCATION CASE INITIATED BY OLIVER BROWN AND OTHER PLAINTIFFS IN KANSAS. UNDERSTANDING THIS BACKGROUND IS CRUCIAL FOR GRASPING THE SIGNIFICANCE OF THE SUPREME COURT'S UNANIMOUS DECISION TO OVERTURN SEGREGATION IN PUBLIC SCHOOLS.
