THE DEFINITION AND IMPORTANCE OF CITIZENSHIP IN THE COMMUNITY

UNDERSTANDING CITIZENSHIP BEYOND LEGAL STATUS

THE ROLE OF CITIZENSHIP IN SOCIAL COHESION

ESSENTIAL RESPONSIBILITIES OF CITIZENS

- OBEYING LOCAL LAWS AND REGULATIONS
- RESPECTING THE RIGHTS AND DIVERSITY OF FELLOW CITIZENS
- PAYING LOCAL TAXES AND DUES FAIRLY
- PARTICIPATING IN CIVIC DUTIES SUCH AS VOTING AND JURY SERVICE
- VOLUNTEERING AND CONTRIBUTING TO COMMUNITY IMPROVEMENT INITIATIVES

WAYS TO PARTICIPATE ACTIVELY IN THE COMMUNITY
