PRINCIPLES OF DEMOCRACY AND THE CONSTITUTION

CORE DEMOCRATIC PRINCIPLES

THE CIVICS EOC EMPHASIZES UNDERSTANDING DEMOCRATIC PRINCIPLES SUCH AS POPULAR SOVEREIGNTY, RULE OF LAW, CHECKS AND BALANCES, AND FEDERALISM. POPULAR SOVEREIGNTY MEANS THAT THE AUTHORITY OF GOVERNMENT IS CREATED AND SUSTAINED BY THE CONSENT OF ITS PEOPLE. THE RULE OF LAW ENSURES THAT LAWS APPLY EQUALLY TO ALL CITIZENS AND GOVERNMENT OFFICIALS. CHECKS AND BALANCES PREVENT ANY ONE BRANCH OF GOVERNMENT FROM BECOMING TOO POWERFUL, WHILE FEDERALISM DIVIDES POWER BETWEEN NATIONAL AND STATE GOVERNMENTS. MASTERY OF THESE PRINCIPLES IS CRITICAL FOR ANSWERING EXAM QUESTIONS RELATED TO THE U.S. POLITICAL SYSTEM.

STRUCTURE OF THE CONSTITUTION

THE U.S. CONSTITUTION IS ORGANIZED INTO A PREAMBLE, SEVEN ARTICLES, AND AMENDMENTS. THE CIVICS EOC REQUIRES STUDENTS TO IDENTIFY THE PURPOSE OF EACH ARTICLE, SUCH AS:

1. **ARTICLE I:** LEGISLATIVE BRANCH - POWERS AND STRUCTURE OF CONGRESS

4. OTHER ARTICLES ADDRESSING STATE RELATIONS, AMENDMENT PROCESSES, AND CONSTITUTIONAL SUPREMACY

CITIZENSHIP AND CIVIC RESPONSIBILITIES

RIGHTS AND RESPONSIBILITIES OF CITIZENS

CIVICS EDUCATION STRESSES THE BALANCE BETWEEN RIGHTS AND RESPONSIBILITIES IN A DEMOCRATIC SOCIETY. CITIZENS HAVE FUNDAMENTAL RIGHTS SUCH AS FREEDOM OF SPEECH, RELIGION, AND VOTING. ALONGSIDE THESE RIGHTS ARE RESPONSIBILITIES INCLUDING OBEYING LAWS, PAYING TAXES, SERVING ON JURIES, AND PARTICIPATING IN CIVIC ACTIVITIES. THE CIVICS EOC TESTS KNOWLEDGE OF THESE CONCEPTS TO ENSURE STUDENTS APPRECIATE THE ROLE OF CITIZENS IN MAINTAINING DEMOCRACY.

PATHWAYS TO CITIZENSHIP

THE CIVICS EOC ALSO COVERS THE PROCESS OF BECOMING A U.S. CITIZEN. THIS INCLUDES UNDERSTANDING NATURALIZATION REQUIREMENTS, THE IMPORTANCE OF ALLEGIANCE, AND THE RIGHTS GRANTED TO NATURALIZED CITIZENS. RECOGNIZING THESE PATHWAYS IS ESSENTIAL FOR UNDERSTANDING THE DIVERSITY AND INCLUSIVENESS OF AMERICAN DEMOCRACY.

BRANCHES OF GOVERNMENT AND THEIR FUNCTIONS

LEGISLATIVE BRANCH

THE LEGISLATIVE BRANCH, CONSISTING OF THE SENATE AND HOUSE OF REPRESENTATIVES, IS RESPONSIBLE FOR MAKING LAWS. THE CIVICS EOC REQUIRES KNOWLEDGE OF THE LEGISLATIVE PROCESS, POWERS GRANTED TO CONGRESS, AND THE ROLES OF ITS MEMBERS. EXECUTIVE BRANCH

THE EXECUTIVE BRANCH ENFORCES LAWS AND IS HEADED BY THE PRESIDENT. IMPORTANT TOPICS INCLUDE PRESIDENTIAL POWERS, THE CABINET, AND EXECUTIVE AGENCIES. THE CIVICS EOC ASSESSES UNDERSTANDING OF HOW THE EXECUTIVE BRANCH IMPLEMENTS POLICY AND MANAGES GOVERNMENT OPERATIONS.

JUDICIAL BRANCH

THE JUDICIAL BRANCH INTERPRETS LAWS AND ENSURES THEY ARE APPLIED FAIRLY. THE CIVICS EOC COVERS THE STRUCTURE OF THE COURT SYSTEM, ESPECIALLY THE SUPREME COURT'S ROLE IN CONSTITUTIONAL INTERPRETATION AND JUDICIAL REVIEW. STUDENTS MUST GRASP HOW COURTS RESOLVE DISPUTES AND PROTECT INDIVIDUAL RIGHTS.

FLORIDA GOVERNMENT AND STATE CONSTITUTION

STATE GOVERNMENT STRUCTURE
