UNDERSTANDING FERPA BASICS

THE FAMILY EDUCATIONAL RIGHTS AND PRIVACY ACT (FERPA) IS A FEDERAL LAW ENACTED IN 1974 TO PROTECT THE PRIVACY OF STUDENT EDUCATION RECORDS. FERPA APPLIES TO ALL EDUCATIONAL INSTITUTIONS THAT RECEIVE FEDERAL FUNDING, INCLUDING K-12 SCHOOLS AND POSTSECONDARY INSTITUTIONS. DEFINITION AND SCOPE OF FERPA

FERPA PROTECTIONS APPLY TO STUDENTS WHO ATTEND SCHOOLS THAT RECEIVE FEDERAL FUNDING. FOR STUDENTS UNDER 18, PARENTS GENERALLY HOLD THE RIGHTS GRANTED BY FERPA. ONCE A STUDENT TURNS 18 OR ATTENDS A POSTSECONDARY INSTITUTION, FERPA RIGHTS TRANSFER TO THE STUDENT. THIS DISTINCTION IS IMPORTANT FOR FERPA QUIZ ANSWERS AND COMPLIANCE POLICIES.

KEY TERMS IN FERPA

UNDERSTANDING THESE EXCEPTIONS IS VITAL FOR CORRECT QUIZ RESPONSES.

HOW LONG DOES FERPA PROTECTION LAST?

FERPA PROTECTIONS REMAIN AS LONG AS THE EDUCATION RECORDS EXIST. GENERALLY, FERPA RIGHTS TRANSFER TO STUDENTS AT AGE 18 OR WHEN THEY ENTER POSTSECONDARY EDUCATION, AND THE LAW CONTINUES TO PROTECT THEIR RECORDS INDEFINITELY.

WHAT IS DIRECTORY INFORMATION AND HOW IS IT HANDLED?

DIRECTORY INFORMATION INCLUDES ITEMS LIKE STUDENT NAME, ADDRESS, AND PHONE NUMBER THAT SCHOOLS MAY DISCLOSE WITHOUT CONSENT UNLESS THE STUDENT OR PARENT OPTS OUT. PROPER HANDLING OF DIRECTORY INFORMATION IS A FREQUENT QUIZ TOPIC.

FERPA RIGHTS AND PROTECTIONS

FERPA'S MAIN PURPOSE IS TO SAFEGUARD STUDENT PRIVACY BY OUTLINING SPECIFIC RIGHTS AND PROTECTIONS. UNDERSTANDING THESE PROTECTIONS IS ESSENTIAL FOR PROVIDING ACCURATE FERPA QUIZ ANSWERS AND MAINTAINING INSTITUTIONAL COMPLIANCE.

RIGHT TO INSPECT AND REVIEW EDUCATION RECORDS

RIGHT TO CONSENT TO DISCLOSURE

EXCEPT UNDER PERMITTED EXCEPTIONS, SCHOOLS MUST OBTAIN WRITTEN CONSENT FROM THE STUDENT OR PARENT BEFORE DISCLOSING PERSONALLY IDENTIFIABLE INFORMATION. THIS RIGHT CONTROLS WHO CAN ACCESS SENSITIVE STUDENT DATA.

PROTECTION AGAINST UNAUTHORIZED DISCLOSURE

FERPA PROHIBITS THE UNAUTHORIZED RELEASE OF EDUCATION RECORDS. VIOLATIONS CAN RESULT IN COMPLAINTS TO THE FAMILY POLICY COMPLIANCE OFFICE AND POTENTIAL LOSS OF FEDERAL FUNDING FOR THE INSTITUTION. STRICT ADHERENCE TO PRIVACY RULES IS CRITICAL.

FERPA COMPLIANCE AND BEST PRACTICES

ENSURING FERPA COMPLIANCE REQUIRES INSTITUTIONS TO IMPLEMENT BEST PRACTICES FOR HANDLING, PROTECTING, AND DISCLOSING STUDENT INFORMATION. THESE MEASURES HELP AVOID VIOLATIONS AND SUPPORT PROPER FERPA QUIZ ANSWERS.

RESPONDING TO FERPA REQUESTS

- LIMITING ACCESS TO RECORDS TO AUTHORIZED PERSONNEL ONLY
- MAINTAINING LOGS OF DISCLOSURES TO TRACK INFORMATION SHARING
- PROVIDING ANNUAL FERPA NOTIFICATIONS TO STUDENTS AND PARENTS

PREPARING FOR FERPA QUIZZES
