UNDERSTANDING FORMALIST CRITICISM

IN THIS CONTEXT, A TEXT'S CULTURE, HISTORY, EVENTS, AND STRUCTURE ARE NOT EXTERNAL ADDITIONS BUT INTEGRAL ELEMENTS THAT INTERACT WITHIN THE FORMAL COMPOSITION OF THE WORK.

UNLIKE BIOGRAPHICAL OR HISTORICAL CRITICISM, FORMALIST CRITICISM SEEKS TO AVOID THE INFLUENCE OF AUTHORIAL INTENT OR READER INTERPRETATION. INSTEAD, IT CONSIDERS THE TEXT'S FORM AS A SELF-CONTAINED SYSTEM WHERE EVERY PART CONTRIBUTES TO THE WHOLE. THIS HOLISTIC PERSPECTIVE ENABLES CRITICS TO DISSECT THE LAYERS OF MEANING ENCODED IN THE TEXT'S ARCHITECTURE AND STYLISTIC DEVICES.

KEY PRINCIPLES OF FORMALIST CRITICISM

THE FOUNDATION OF FORMALIST CRITICISM RESTS ON SEVERAL ESSENTIAL PRINCIPLES THAT GUIDE ITS ANALYTICAL PROCESS:

- **DEFAMILIARIZATION:** IDENTIFYING TECHNIQUES THAT MAKE THE FAMILIAR SEEM STRANGE AND PROVOKE FRESH PERCEPTION.

THE ROLE OF CULTURE IN FORMALIST CRITICISM

WHILE FORMALIST CRITICISM TRADITIONALLY CONCENTRATES ON THE TEXT'S INTERNAL FEATURES, IT ALSO ACKNOWLEDGES THAT CULTURAL ELEMENTS ARE EMBEDDED WITHIN THE WORK'S LANGUAGE AND SYMBOLISM. YES, FORMALIST CRITICISM CAN BE COMBINED WITH OTHER APPROACHES LIKE HISTORICAL OR CULTURAL CRITICISM TO PROVIDE A MORE COMPREHENSIVE UNDERSTANDING OF A TEXT.
